
WELCOMING WINTER

Here's what's happening:

- **Guideline Updates:** The Modification Committee is finalizing updates to guidelines for modern design, landscaping, and architecture.
- **HOA Office Plans:** We're evaluating options for the onsite HOA office and will present them at the next Open Meeting on February 10th. This will kick off a community vote to decide on next steps.
- **Meeting Streaming:** We're working to enable streaming for Open Meetings. It's been trickier than expected, but we now have a solid plan and aim to roll this out soon.
- **Reserves Study:** We are looking into updating the reserves study to help in finalizing the Top 10 maintenance and repair priorities for 2025.

COMPLIANCE CORNER

Our last Twin Creeks Community Association Survey revealed that “compliance issues” are some of our neighbors’ chief items of “dissatisfaction”. Our next survey will focus on this area to receive more specific feedback so that the Board, and CMA, can direct attention to remedial activity.

We believe that some of our neighbors may not realize many of the actions (or lack of actions) that constitute compliance violations of Homeowner Regulations. In this column of the Newsletter, we will highlight a couple of items each month of most immediate relevance:

1. **Holiday Outdoor Decorations Reminder:** these may be installed as early as November 15, and removed by January 15.
2. **Landscape Maintenance of Appearance** has a list of guidelines to help retain visual enjoyment, home values, and pride in the reputation of Twin Creeks for a high-quality environment. In the Fall, front yard leaves may need to be raked several times both for appearance, and to prevent them from blowing into the street drains where unclogging can be hazardous and expensive. Please do not neglect to do your part by wishing that they blow into your neighbor’s yard, or the street. Put them in yard waste paper bags, and CWD will pick them up every week on your regular trash schedule.





Turkey Biscuit Stew

Prep Time 15 min
Cook Time 20 min
Yield 8 servings

Ingredients

- 1/3 cup chopped onion
- 1/4 cup butter, cubed
- 1/3 cup all-purpose flour
- 1/2 teaspoon salt
- 1/8 teaspoon pepper
- 1 can (10-1/2 ounces) condensed chicken broth, undiluted
- 3/4 cup 2% milk
- 2 cups cubed cooked turkey
- 1 cup cooked peas
- 1 cup cooked whole baby carrots
- 1 tube (16.3 ounces) large, refrigerated buttermilk biscuits



Directions

1. Preheat oven to 375°. In a 10-in. cast-iron or other ovenproof skillet, sauté onion in butter until tender. Stir in the flour, salt and pepper until blended. Gradually add broth and milk. Bring to a boil. Cook and stir until thickened and bubbly, about 2 minutes. Add the turkey, peas and carrots, heat through. Separate biscuits and arrange them over the stew.
2. Bake until biscuits are golden brown, 20-25 minutes.



The answer is none of the above! Through time, the Twin Creeks name has been used in so many ways that the various uses seem to all blend together. Here’s a some positioning to clarify:

The Golf Club at Twin Creeks originated in 1995, just shortly after our community was incorporated. A popular golf course designed by Arnold Palmer, the marketing of the two entities was sometimes entwined early on in order to help each other become established, but they are not affiliated in any way.

Twin Creeks Allen Texas Residents Facebook page - this and a few other Facebook groups include the Twin Creeks name but are not affiliated in any way with our Twin Creeks Community Association. It is the goal of TCCA to publish an officially-supported Facebook page this year.

Twin Creeks Crossing is a relatively new apartment complex on Exchange Parkway that is often thought to be a part of our Twin Creeks Community Association given its name and proximity. It’s not affiliated in any way.

These are just a few of the dozens of entities with the Twin Creeks name. The history of how this evolved is interesting and we’ll be sharing more of this insight through time!


Working for You...
