COURTESY PATROL

Executive Sentinels began providing **mobile courtesy patrol services** in our community in 2025.

You will be seeing them in and around the community and we hope you make their acquaintance.



Their **primary role is to monitor the common areas and assets of the community** and to **enhance the safety of our neighborhood by observing and reporting any issues** they encounter during their patrols.

Some of the key areas of focus for the mobile courtesy patrol team include:

- Monitoring common areas and non-resident use of those areas.
- Reporting residents causing disruptions or violating community rules.
- Identifying open garages.
- Addressing parking issues when/if they arise, particularly in the common areas.
- Reporting unauthorized solicitors in the community.

Securing Your Garden Plot

The gardening year begins annually in January. Interested in renting a plot, please reach out now to select your space and begin gardening with your neighbors.

The cost is \$225 for new gardeners and \$75 for returning gardeners. These fees help cover the costs of organic dirt, which is delivered each Spring, as well as the timer, soaker hose, and general maintenance expenses of the garden itself.

Garden Plots & Details

Each member of the community garden is provided a plot with irrigation, a soaker hose, timer, and organic dirt to begin. Residents purchase their plants and harvest their own organic goods in a few months. The many experienced gardeners are always happy to help new gardeners with any questions.

SOLICITATION



The City of Plano no longer requires permits for solicitation. However, there is a city ordinance that addresses trespassing and soliciting as well as solicitation and handbill distribution on private property.

Section 11-141 permits certain “no trespassing” signs. A sample is available to download at the CMA homeowner portal, LakesideOnPreston.com, and available as the last page of this newsletter. Yards signs are also available on Amazon.

If you have a publicly visible “no trespassing” sign posted and solicitors are on your property, please call the non-emergency line at 972-941-5678. You may report any violation, remaining anonymous if you prefer, and an officer will contact the solicitor regarding the violation.
