Dear Members of The Nelson Golf & Sports Club,

We are writing to announce an update to our Private Cart Policy, effective January 1, 2026. This policy update is designed to ensure the proper management, safety, and maintenance of our cart paths and club facilities for all Members.

Policy for Golf Members

The updated policy introduces an annual Trail Fee for private carts operated by Golf Members who are not enrolled in the "Club 30 Plus" annual program.

- **Trail Fee:** Golf Members who are not enrolled in the "Club 30 Plus" annual program will be subject to an annual Trail Fee of \$1,250 + sales tax, Billed 12/31/2025
- **Registration and Identification:** All private carts must be registered with the Golf Shop prior to operation on Club property and sign agreement. Furthermore, registered carts must prominently display the current year's annual sticker near the carts' rear bumper. Member's last name must be displayed on the body of the cart below the seat. (must be ordered through the Club)
- **Requirements:** Carts belonging to Golf Members must undergo an inspection, provide current proof of liability insurance (\$1,000,000) and include The Nelson Golf & Sports Club as additional insured., The private cart must meet all additional operational and aesthetic requirements established by The Nelson. Please contact the Golf Shop to schedule your inspection and review the full requirements.
- **Private Cart Driver:** Must have a valid driver's license without exception.

Members enrolled in the "Club 30 Plus" program are exempt from this annual Trail Fee and must comply with all other requirements.

Policy for Non-Golf Members

For Members holding non-Golf memberships who wish to operate their private carts on The Nelson cart paths (e.g., for accessing certain club facilities), a separate policy applies.

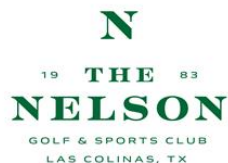
- **Trail Fee:** The applicable annual Trail Fee for registered Non-Golf Members is \$300, + sales tax, Billed 12/31/2025. Furthermore, registered carts must prominently display the current year's annual sticker near the carts' rear bumper.
- **Requirements:** Carts belonging to Non-Golf Members must undergo an inspection, provide current proof of liability insurance (\$1,000,000) and include The Nelson Golf & Sports Club as additional insured, and meet all additional operational and aesthetic requirements established by The Nelson. Please contact the Golf Shop to schedule your inspection and review the full requirements and sign the agreement. Member's last name must be displayed on the body of the cart below the seat (must be ordered through the Club)
- **Private Cart Driver:** Must have a valid driver's license without exception.

Important Notice to Non-Members

Please be advised that individuals who are not current Members of The Nelson Golf & Sports Club **do not have permission** under any circumstance to operate or drive private carts on Club property, including cart paths. This policy is strictly enforced to ensure Member security and property safety.
